## TUITION AND POLICY AGREEMENT FORM



2026-2027

I, the undersigned, do hereby agree to comply with the educational policies and regulations of the Toledo Islamic Academy Parent / Student Handbook.

I agree to pay the registration fee, tuition and other fees for the 2026-2027 school year. The registration fee is due at the time of student registration and is **non-refundable**.

I realize that bills are sent on the 15th of the month. A late fee of \$50.00 will be added monthly if tuition payment is not received by the 28th of the month. Tuition that is 30 days past due is reason for dismissal and/or refusal for acceptance for the following school year. Registered accounts with Tuition Management System (Facts/ TMS) must follow the dates of their cycle. Late fees also apply with TMS. **A late fee of \$300.00 per student will be added for registration after July 28<sup>th</sup>. for Returned Students Only.**

Toledo Islamic Academy is committed to providing students and their families a range of options for paying for their educational expenses. The credit card payment method is becoming prohibitively expensive because of the fees to TIA for credit card transaction processing. This expense is paid by the Academy tuition revenues and therefore reduces the tuition dollars available for academic programs and services for all students. **Therefore, a convenience fee on credit card transactions in the amount of 4% will be charged for every transaction.**

I realize that checks returned due to insufficient funds will be billed an additional \$35.00. I am also responsible for any insufficient fund's charges incurred by the school due to inadequate funds to cover any check I write to the school. If returned checks happen more than once, the school will require future payments to be made in cash. Any issues regarding payment of fees must be directed to the Finance Office.

I understand that the tuition paid only covers a portion of what is needed to operate the school and meet the needs of a high-quality educational program. I recognize that the school must receive the agreement and payment no later than the specific dates set forth above. Should an account become delinquent, or the direct debit default, the entire balance of all tuition, fees and commitments referenced in this Agreement shall be immediately due and payable. The school reserves the right to delay enforcing any penalties outlined in this Agreement without affecting any of my rights to declare a default on that or any subsequent payments. Any payments made to a delinquent account will be applied to the most outstanding portion first. Matters regarding changes in one's financial condition should be communicated to the Finance Office only, and will be held in confidence, except that the Office will evaluate the matter, if necessary, with the TIA Education Committee and Principal.

I understand that I am obligated to make the tuition payments regardless of illness, family vacation, or my child's other absences from school. In addition, I understand that if my account becomes more than 30 days past due, my child may lose his or her position in the school or not be admitted to the classes and I may be subject to collection and /or legal proceedings. I understand that, should collection efforts on my bill become necessary, I am responsible for all collection and legal fees.

Acceptance of students into TIA means that the family of the student is also accepted into the school community. Students and their families are expected to contribute and be actively involved in the TIA community at the school. **Therefore, TIA requires each family to volunteer 10 hours per student and a maximum of 25 hours per family per school year. If the family decides not to volunteer the required hours, a fee of \$100 per student or \$250 per family will be added to the last tuition instalment.**

The parents or guardians are responsible and required to pay the tuition in full. If you are enrolled with Facts/ TMS and tuition payments are not made at the scheduled time, FTMS will send out notices and financial charges will apply.

Payments of all delinquent accounts must also be according to the plan selected. Accounts that are delinquent will result in temporary exclusion of your child from school. If any tuition or fees remain outstanding at the end of the school year, your child will not be admitted the following year until the account is paid in full, and all school records (report card, transcript, etc.) will be withheld.
